June 14, 2024	Pennsylvania	Flag Day
June 17, 2024	Utah	Juneteenth Day
June 19, 2024	Nebraska, Rhode Island	Juneteenth Day*

**Louisiana's Governor may proclaim Juneteenth Day as a holiday.*

**Nebraska allows calls on Sundays and legal holidays but limits prerecorded messages to 1 pm-9 pm on those days with exceptions.*

State Exemption Master

Telemarketing is illegal on state holidays in Alabama, Louisiana, Mississippi, Pennsylvania, Rhode Island and Utah; however the following exemptions may apply:
